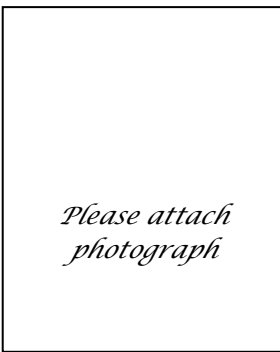

Students accepted into the program will be notified by April 18th, 2011.

The Erasmus accommodation fund also provides €420 towards your room and board expenses during your 3-week stay. The student will be responsible for any outstanding balance owed to the hotel. Students should calculate their financial costs depending on whether they choose full board or half board accommodation.

Full board is €53/day for 21 days (including bed, breakfast, lunch, and dinner), totaling €1,113 - €420 (Erasmus accommodation grant) leaves an outstanding balance of €693 to be paid by the student.

Half board is €41/day for 21 days (including bed, breakfast, lunch OR dinner), totaling €861 - €420 (Erasmus accommodation grant) leaves an outstanding balance of €441 to be paid by the student.

Application Deadlines & Deposit Requirements:

April 12th – Deadline for receipt of applications.

April 18th – If you are accepted into the program, you will be notified by email and phone. The institutional coordinator will explain to you how to remit your deposit via bank transfer or cash.

April 20th - Your deposit is due and must be received in order to secure your place in the Summer School Program (€175 for Queen's University and Mykolas Romeris students, €275 for University of Cyprus students)*.

May 25th - Electronic proof of purchase of your airline ticket must be received by the Institutional Coordinator. Please note, the Erasmus credit for airfares will be as follows: for UK students, €500; for Lithuania students, €650.*

*The deposit for University of Cyprus students is calculated as €175 plus their cost of transportation (gas/taxi).

Half board at Rodon Hotel (includes breakfast, lunch or dinner): €41 per day for a double room (two people) = €861 - €420 (Erasmus accommodation grant) leaves an outstanding balance of €441 that I, the student, am responsible for; OR,

Full board at Rodon Hotel (includes breakfast, lunch and dinner): €53 per day for a double room (two people) = €1,113 - €420 (Erasmus accommodation grant) leaves an outstanding balance of €693 that I, the student, am responsible for.

Applicant's Acknowledgement of Conditions:

I have read the instructions regarding this application form and understand that my application will NOT be considered if the required documentation is incomplete.

I understand that the maximum the Erasmus travel fund can cover me for my airfare is: €500 for UK students, €650 for Lithuania students, and €100 (gas and/or taxi) for students from Cyprus. If the airfare ticket is more expensive than the above amounts I will be expected to pay the difference.

Should I decide to cancel my participation in the program after purchasing my airfare ticket, I understand that I will receive no refund of my airfare.

I accept The Erasmus Accommodation Award of €420 to cover part of my accommodation expenses in a double room shared with another student from July 31st to August 21st, 2011 at Rodon Hotel, Agros in Cyprus.

I understand that if I am accepted into the program, I must attend all classes, which means that I will be at Rodon Hotel from July 31st through August 21st, 2011.

I also understand that participation in field trips and social and cultural events organized with other students are obligatory.

I understand that I will have to submit a final evaluation report at the end of the Summer School and that, upon successful completion of my coursework, I will receive a certificate indicating that I have earned 5 ECTS. The manner in which these ECTS are applied will be determined by my home Department or School.
