Erasmus+ Mobility for Studies (SMS)

From 2 February 2026 to 25 February 2026, we invite students to apply for Study mobility for the 2026/2027 academic year, Autumn semester, selecting three universities in order of priority.

The country and university of interest for studies in the Autumn semester 2026 can be chosen from this list.

To study at universities in Programme Countries (mostly EU and associated countries), select "Erasmus+ studies KA131" in the Mobility-Online application. For studies at higher education institutions in third countries not associated with the Erasmus+ Programme, select "Erasmus+ KA171 studies". Choosing "Bilateral Exchange" in the application indicates that students will fund their studies independently.

Applications for Erasmus+ study mobility are open only to students who are enrolled at MRU and physically present in Lithuania, are in the second semester of their first year of undergraduate studies, and, for non-EU students, hold or have applied for a Lithuanian temporary residence permit (TRP). Mobility may take place no earlier than the second year (third semester). More information on the organisation of outgoing study mobility at MRU can be found in the regulations here.

On Wednesday, 11 February 2026, at 4:00 PM, we invite you to join the Erasmus+ online information seminar. The seminar will provide an overview of the opportunities available through the Erasmus+ programme and explain the requirements for participating in student mobility. It will be conducted in English and will be recorded. Access link – here.

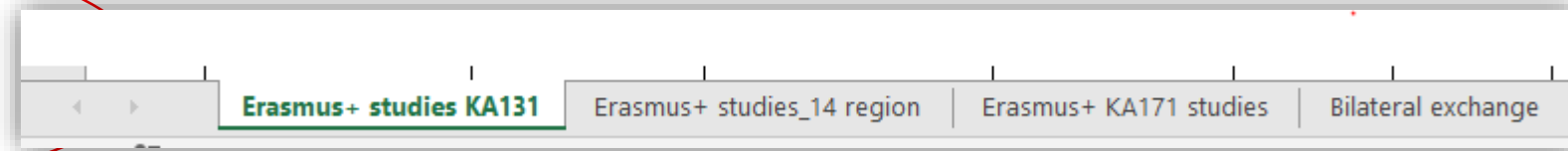

- ✓ Studies at partner universities worldwide without an Erasmus+ grant are referred to as **“Bilateral Exchange”** Students applying for these exchanges must be prepared to fund their studies independently.



Plan finances



The *Erasmus+* grant for studies is a Grant awarded by the University for the student who participates in the *Erasmus+* mobility for studies (minimum eligible duration of **physical mobility** to another country is 3 months).

Foreign Students going for Erasmus+ mobility **MUST** have TRP (Temporary Residence Permits) of Lithuania and the TRP of Lithuania must be valid during the entire mobility period.

While having a TRP of Lithuania (it proves that you are an outgoing mobility participant from Lithuania) you might also have to apply for relevant permission in the host country (e.g. VISA), if such is a requirement of the host country for incoming students for **longer** than 90 days.

Check if and when you need to apply for VISA and Temporary Residence Permits for studies at the Partner University.
